Statement of Purpose (from 1st August 2018)

Aims and objectives

Street Medical Practice aims to provide a high standard of private medical practice in a confidential and safe healthcare environment, delivering skilled, comprehensive, evidence based, individualised healthcare. We aim to provide the best diagnosis and the best treatment with the best possible outcome.

Street Medical Practice's objective is to thoroughly assess each patient's health condition with their consent; respecting, supporting and encouraging the right to individual choice and personal decision-making which meets and exceeds expectations, whilst complying with the Care Quality Commission (Registration) Regulations 2009, and the fundamental standards and regulations of the Health and Social Care Act 2008 (Regulated Activities) Regulations 2014.

Kinds of healthcare services provided by Street Medical Practice

Street Medical Practice provides private General Practitioner (GP) healthcare services in the form of the following regulated activities:

• Treatment of disease, disorder or injury

This includes private GP consultations, physical examinations, health assessments, the prescribing of medicines in relation to general medical problems including acute and chronic medical conditions relating to male and female health, childhood immunisations, travel vaccinations, and referrals to other healthcare specialists as necessary.

• Diagnostic and screening procedures

These include blood tests, urine tests, cervical smears, ECGs, respiratory testing, and taking swabs.

• Maternity and midwifery services

This includes antenatal care and postnatal care up to 6 weeks following birth.

Street Medical Practice provides consultations and treatments in accordance with patients' health needs but always subject to strict medical assessment. During an initial consultation, an individual general medical history will be taken and patients will be advised of proposed treatments including full costs, which will be fully explained prior to proceeding.
